What is a zoning ordinance for solar energy?

This document is intended to provide guidance to local governments considering developing an ordinance or rules related to the development of utility-scale solar energy systems that are permitted as a conditional use by the local government's zoning code.

Should landowners consider a solar energy project?

When considering a solar energy project, landowners and producers are encouraged to visit their local USDA Service Center⁶ to discuss the potential program and land use classification impacts of siting solar facilities on their land before committing to a solar land lease or installing an on-farm solar array.
